Send cash or money orders. **Pre-registrations must be postmarked one week prior to the show.** I have read the Unique Motor Sports rules and regulations and agree to follow them. I accept the decision of the judges as final and elect to use the grounds or track as presented. I agree to have my car at the race location and signed in at least 1 hour prior to the show time or I will be ineligible to run. No alcohol in pit area.

The undersigned hereby represents and certifies that:

1. I have read the Unique Motor Sports rules & regulations and agree to follow them
2. I have voluntarily entered this event
3. I understand the promoter does not provide medical insurance coverage or emergency transportation
4. I understand that pre-registrations must be postmarked one week prior to the show - send cash or money order - NO CHECKS
5. I accept the decision of the judges as final and elect to use the grounds or track as presented
6. I agree to have my car at the race location & signed in at least 1 hour prior to the show time or I will be ineligible to run
7. I am at least 18 years of age OR parent/guardian will need to sign waiver day of show. Driver must be able to provide proof of age & picture ID - driver's license or state issued photo ID card
8. I understand that at any time during a UMS event a driver &/or pit person(s) can be asked to leave event for any reason
9. I understand that if I place and receive money that my SS# will be required & I agree to provide
10. Dates, times, payout, classes subject to change without notice
